LOCAL LAW #4 -2013

A LOCAL LAW to amend Chapter 102 of the Town Code of the Town of Putnam Valley (Stormwater Management and Erosion and Sediment Control) so as to extend the coverage of said Chapter to construction activities resulting in more than 5,000 square feet of soil disturbance within the New York City Watershed.

BE IT ENACTED by the Town Board of the Town of Putnam Valley as follows:

(1) Section 102-6 of the Town Code be and is hereby amended so as to revise the definition of "Land Development Activity" to read as follows:

"Land Development Activity- construction activity including clearing, grading, excavating, soil disturbance or placement of fill that results in land disturbance of equal to or greater than one acre, or activities disturbing less than one acre of total land area that is part of a larger common plan of development or sale, even though multiple separate and distinct land development activities may take place at different times on different schedules *or, with respect* to properties in the New York City watershed, construction activities resulting in more than 5,000 sq. ft. of soil disturbance."

(2) This Local Law shall take effect upon its filing with the New York State Secretary of State.


